

**THE GET OUTSIDE WITH EVOLVE SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

The Get Outside With Evolve Sweepstakes ("Sweepstakes") is sponsored by CytoSport, Inc. ("Sponsor"), 433 W. Van Buren Street, Chicago, IL 60607 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on April 15, 2021 at 12:00 PM Eastern Time ("ET") and ends on May 31, 2021 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of one of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

**3. HOW TO ENTER THE SWEEPSTAKES: There are three (3) ways to enter the Sweepstakes:**

- A. **Website:** During the Sweepstakes Period, an eligible entrant may visit DrinkEvolveSweeps.com ("Website") and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. Upon the successful submission of the registration information, an entrant will receive one (1) entry into the Sweepstakes.

**Note:** During the Sweepstakes Period, an entrant may also text EVOLVE ("Keyword") to 22639 ("Short Code") to obtain a link to the Website. **Note that an entrant cannot participate in the Sweepstakes solely by texting the Keyword to the Short Code. Message and data rates may apply for each text message sent or received.** Not all mobile telephone providers carry the service necessary to access the Website. Entrants should consult their wireless providers' pricing plans. Msg&data rates may apply. Consent not a condition of purchase. An entrant may, at any time, choose to stop participating in this Sweepstakes by sending an opt-out text message stating "STOP EVOLVE" to the Short Code. If an entrant sends an opt-out text message, he/she will be sent a reply text message, which will confirm that he/she has been unsubscribed and will receive no further text messages. **B. Twitter:** An entrant may follow the steps below to receive an entry:

- i. Sign into his/her Twitter account (entrant may create a Twitter account for free if he/she does not already have one);
- ii. Become a follower of @DrinkEvolve on Twitter (if not already following @DrinkEvolve). There is no charge to sign up for Twitter or to follow @DrinkEvolve; and
- iii. Compose a new Tweet sharing which national park you dream of visiting, including the hashtags “#GetOutsideWithEvolve” and “#Sweepstakes” and tag @DrinkEvolve to receive one (1) entry into the Sweepstakes.

**C. Instagram:** An entrant may follow the steps below to receive an entry:

- i. Sign into his/her Instagram account (entrant may create an Instagram account for free if he/she does not already have one);
- ii. Become a follower of @DrinkEvolve on Instagram (if not already following @DrinkEvolve). There is no charge to sign up for Instagram or to follow @DrinkEvolve; and
- iii. Compose a new Instagram post sharing which national park you dream of visiting, including the hashtags “#GetOutsideWithEvolve” and “#Sweepstakes” and tag @DrinkEvolve to receive one (1) entry into the Sweepstakes.

The content included in the entry will not be judged or used in any way to determine a winner. By entering the Sweepstakes and using the hashtags “#GetOutsideWithEvolve” and “#Sweepstakes”, entrant hereby agrees to be bound by these Official Rules. Entries will be deemed made by the authorized account holder of the Twitter or Instagram account the entry is submitted from at the time of entry. The “authorized account holder” is the person who is assigned to the Twitter account or Instagram by the online service provider. An entrant must have a non-private Twitter account or Instagram account to enter the Sweepstakes and must be a follower of @DrinkEvolve on the platform used to enter until June 30, 2021 for potential winner notification purposes to be eligible to win/claim a prize. If an entrant does not have a non-private Twitter account, he/she can create one at no cost by visiting [www.twitter.com](http://www.twitter.com). Due to the way Instagram operate its services, entries from users with protected or private accounts (i.e., entrant has set his/her account so that only people the entrant has approved can view his or her updates) may not be received. If an entrant enters from his/her wireless phone, the entrant’s wireless service provider may charge the entrant. 5. **PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:**

  - B. **First Prizes (50):** Each first prize is one (1) 2021 America the Beautiful - National Parks & Federal Recreational Lands Annual Pass (each a "First Prize"). No more than fifty (50) First Prizes will be available in the Sweepstakes. The ARV of each First Prize is \$80.
  - C. **Second Prizes (100):** Each second prize is one (1) case of EVOLVE Plant-based Protein Shakes (each a "Second Prize"). No more than one hundred (100) Second Prizes will be available in the Sweepstakes. The ARV of each Second Prize is \$26.99.
  - D. **Total ARV:** The total ARV of all prizes in the Sweepstakes is \$16,699.
  - E. **Odds of Winning:** The odds of winning a prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.
  - F. **General Conditions:** There is a limit of one (1) prize per person. In no event will more than one (1) Grand Prize, fifty (50) First Prizes, one hundred (100) Second Prizes be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received.

After the random drawing, Administrator will notify the potential winner either via e-mail at the e-mail address provided at the time of registration or on either Twitter or Instagram by a Direct Message from @DrinkEvolve (depending on his/her method of entry) with instructions on how to claim his/her prize. The potential winners must respond to Twitter/Instagram Direct Message winner notification within twenty-four (24) hours or they may, at the Sponsor's sole discretion, be disqualified. The potential Grand Prize winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered Direct Messages, e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH**

**RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
